# WARRANTY - 10 YEARS

This ten year material warranty is only available through contractors who have obtained certification as a KM Coatings Approved Applicator. Warranty coverage is subject to the terms and conditions of the KM Coatings Approved Applicator Agreement. An installation labor warranty may be provided by the Applicator.

KM Coatings Mfg., Inc. of Phoenix, Arizona does hereby warrant, to the building owner, Primebase, Finalcoat, Foamguard and Acrylicalk to be free from manufacturers' defects for a period of ten years. Our products shall not be warranted unless applied in accordance with the manufacturer's printed specifications and instructions and applied by an Applicator approved by KM Coatings, Mfg., Inc.

Written notice of claims and a copy of an authorized Warranty Registration Card must be sent to KM Coatings Mfg., Inc. within ten days of a roofing system failure. The Manufacturer reserves the right to examine and test any such systems failure. The Manufacturer reserves the right to examine and test any such system failure prior to settlement and may elect to either repair or replace the defective product at our option. The Manufacturer shall not be liable for consequential damages of any kind. Manufacturers' defects do not include deterioration of the coating due to non-draining or ponding water condition. Ponding water is defined as a pond of water that stands continuously without running off naturally or evaporating within 48 hours. The Manufacturer does not warranty against defective installation, abuse, neglect, structural or substrate failure, excessive foot traffic or acts of God, war or civil disturbance. The product shall be used as supplied by the Manufacturer and shall not be thinned or altered in any way. The warranties contained herein are the only warranties made by the Manufacturer, and no other warranties, expressed or implied, are given on these products.

The Warranty Registration card below must be completed and submitted to KM Coatings Mfg., Inc. by the Approved Applicator within thirty days of the original application in order to obtain warranty coverage. The Building Owner shall contact the Approved Applicator, of whom initially installed the KM Coatings Mfg., Inc. System, prior to the processing of any warranty claim. Failure to do so will render warranty null and void.
